

The Coalition of Haliburton Property Owners Associations – overview

- A Non profit, all volunteer, Ontario licensed corporation
- Founded in 2008 by 23 lake associations
- Now has 50 LA and over 100 lakes (17,000 properties)
- Has only One Goal & One Vested Interest
 - To protect and enhance the lakes of Haliburton Highlands
 - We do not have vested interests in \$ or status just in lake health
- Managed by an 8 member Board (experienced in Managing, Marketing, \$, Strategic Planning, Educating etc..)
- Funding
 - 8% by member fees from LA
 - 92% from funding agencies (\$428k) & social enterprise(\$32k)
- Great working relationships with numerous orgs, funders & government

C.H.A. way of operating

- Integrity and professionalism above all
 - Actions based on best available science
 - Keep learning up to date
 - All materials peer reviewed
 - Treat all with respect
 - Educate before legislate
 - Proactive to prevent lake health issues



The scientific advice we got

- We have been turning to the # 1 lake health expert in Ontario (Dr. Norm Yan) since our 1st year
- In 2009 I met with Dr Yan and Dr Andrew Paterson and asked them
 - How do we know when we have a problem?
 - What should our priority be?

Their strong, unequivocal answer

- While testing is important
 - When you know you have a problem it is already too late
 - Therefore act now to prevent problems

The 2 highest priority areas

- Septic Health
- Protecting and reestablishing Natural Shorelines





I continue to check in with Dr Yan regularly

Our Operating mode

- Act now to prevent problems don't wait
 - Do not take on projects that are already a responsibility of another org such as FOCA, CEWF etc
- Focus on one priority at a time
 - Set goal
 - Determine obstacles
 - Develop solutions
 - Implement
 - Be persistent
- Educate before legislate
- Professionalism = integrity, Peer review all materials, act professionally

Understand each player – in as much detail as possible


- Who are the decisions makers

Tailor the message to each org and decision maker


Be trusted and keep adding trust

Natural Shorelines

- <u>Direct</u> relationship to lake health
- 80-90% of all lake life
- Minimum = 75% lake back 30 metres
- Habitat
 - Benthics, Fish, Frogs, butterflies
- Filtering Phosphorous & other Pollutants



1 reason Natural Shorelines Are Critical





Natural Shorelines

- 1st step research on issue
- 2nd education and train the trainers
- 3rd step where do we stand vs the 75% necessary =
 - Partners
 - Trent U
 - Watersheds Canada
 - Canadian Wildlife Federation
 - Most ambitious program of the C.H.A.
 - 4+ years of work -
 - 12,592 volunteer hours = 6.7 person years
 - \$300,000 budget 95 % from funders
 - 13,484 Properties & 13,484 Reports =
 - 1,072 Kms of shoreline (Minden to Baltimore Maryland)
 - 2X More lots done in 4 years than Muskoka WC has done in 8 years



- Results 92% of lakes need renaturalization
- Average = 47% Natural vs 75% needed
- Next Steps
 - Survey of property owners to determine obstacles to renaturalization
 - Motivation
 - Knowledge of how
 - Who
 - Educate & Provide tools
 - 30 demo renaturalizations on lakes
 - Ribbon of Life & Beginners Guide To Shoreline Renaturalization Videos Fleming College
 - Tip sheets
 - Ribbon of Life Bags filled with info
 - Media campaign
 - Healthy Lakes Contest
 - Tax Bill Insert
 - Tools
 - Videos
 - Slope, Soil type
 - Plant Selection Guide
 - Worked with Local companies, Watersheds Canada Natural edge, Master Gardeners








Education is not enough

- Public Opinion
 - Surveys by lake assoc
 - Some professionally designed and implemented
 - Results
 - Communicate with Council

- Contacts
 - Identify key influencers for each council member
 - Identify sympathetic influencers
 - Reach out
 - Discuss best strategy for approach
 - provide tools
 - Implement
- Organizations
 - Meet and discuss
- Reinforce in advance of each meeting
- Change strategy as needed
- Constant ear to ground



Be Prepared for nasty

- Council members
 - Nasty emails
 - Threats of legal action
 - Threats of election consequences
 - Came to nothing
- Threats to supporters
 - Personal examples



Our Mistakes

- Clearly communicate the Why
- Coles notes version
- Don't let the opponents control the discussion
- Need social media
- Took too long
 - Keep focus on from start to finish
 - staff and Council



Our recommendations for any bylaw

- Permit based system not complaint based
- Covers
 - All vegetation not just trees
 - Moving soil
 - Changing slope
- Allows
 - Path to lake
- Penalties
 - Apply to homeowner and contractor
 - Strong enuf to dissuade
